This document contains important information about the personal data processed by Agras Delic S.p.A. (a sole shareholder joint-stock company) when visiting and/or interacting with this website.

Please read the privacy policy carefully before submitting personal information of any type and/or filling out any online form on the website www.schesir.com. This notice is provided pursuant to article 13 of Regulation (EU) 2016/679 (GDPR) for this website only (it does not apply to other linked websites).

A) Data controller

The data controller is Agras Delic S.p.A. (a sole shareholder joint-stock company), with registered office in Milan, Viale Bianca Maria 25, and operating unit in Genoa, Via Martin Piaggio 13 A, VAT number 03765340967.

B) Personal data collected

B.1 Browsing data. The IT systems and software procedures used in the course of the normal operation of the website collect certain personal data whose transmission is implicit in the use of internet communication protocols. This data includes the IP (Internet Protocol) addresses or domain names of the computers used to access the website, the URL (Uniform Resource Identifier) addresses of the resources requested, the time of the request, the size of the file obtained in response, the numerical code indicating the status of the response given by the server, and other parameters relating to the user's operating system and IT environment. This data is used for the sole purpose of obtaining anonymous statistical information on website use and to check that it is operating correctly. The data could be used to establish responsibility in the event of alleged cybercrimes committed against the site. B.2) Data submitted voluntarily by the user/visitor. The voluntary submission of personal data to Agras Delic (including by e-mail) entails the subsequent acquisition of such data, which is needed to respond to your requests and/or enter into negotiations or contractual relations with you. C) Legal basis and purpose of processing

Your personal data is processed by Agras Delic exclusively for one or more of the following purposes:

1. to enable you to complete your registration on the website.

In this case, the legal basis for the processing of your personal data is your request. Without this information, it is impossible to process and therefore complete your registration on the website or to enter into pre-contractual or contractual relationships.

2. to offer you promotions and/or marketing opportunities.

In order to allow this additional processing of your personal data, we need to obtain your consent. You are free to refuse to give your consent, in which case Agras Delic will not engage in marketing activities.

D) Method and duration of processing

The data collected is processed by Agras Delic in compliance with the principles of lawfulness, fairness, transparency, limitation of the purposes of retention, data minimisation, accuracy, integrity and confidentiality.

Processing is performed electronically and/or on paper, with the use of security measures to ensure the confidentiality of personal data and avoid improper access by unauthorised persons.

Your personal data will be retained for the entire duration of your relationship with Agras Delic and, in the event of cancellation, for a further period of 10 years, also for the purposes of complying with legal obligations. After this period, Agras Delic will delete your personal data.

E) Categories of recipient

In order to properly carry out all the processing operations needed to pursue the objectives set out in this privacy policy, the following recipients may be involved in the processing of your personal data:

- Agras Delic employees charged with processing your personal data. Said persons will be given specific instructions regarding security and the correct use of your personal data;
- third parties appointed as Data Processors to perform processing operations on behalf of Agras Delic.

F) Rights of the data subject

At any time, in accordance with the conditions established by the law, you have the right to apply to Agras Delic to gain access to your personal data, to modify or delete same, and likewise to withdraw your consent or restrict processing. You may also object to the processing of your data and exercise your right to data portability.

If you believe your personal data has been processed in breach of the law, you may lodge a complaint with the Data Protection Authority.
